

Privacy Policy

Online Purchasing

Customers' personal Credit Card information, gathered whilst in the process of conducting an online purchase, will be used only for Credit Card authorization purposes. This information will be shared with our Payment Processing Authority, only in the context of purchasing Merchandise &/or Products.

Safari Coffee does not store any credit card information. All credit card processing is securely conducted via Mollie, using the financial industry's Secure Socket Layer (SSL) standards. We also offer PayPal for your convenience. PayPal utilizes the same SSL protocols with an encryption key length of 128-bits (the highest level commercially available).

Customers' other personal information, gathered by Safari Coffee whilst in the process of conducting an online purchase, may also be used to inform the customer of additional products, special offers and services, which Safari Coffee believes will be of interest to them. All marketing materials sent to the customer will include an option for the customer to request removal from mailing or contact lists for any future marketing.

Personal information will not be shared, sold, exchanged, leased or given to any third party not connected to the business of supplying products and services from Safari Coffee.

What does other personal information mean?

Personal data gathered for the purpose of providing a specific service or product as requested by the customer. This information may include the customer and recipients' full names, postal and billing addresses, email addresses and contact phone numbers.

Credit Card Security

We accept MasterCard and Visa. All online credit card transactions are conducted directly by Mollie using secure 128-bit encryption software. Your personal credit card details are not stored on any server.

Email Submissions

All email addresses submitted to the web site of Safari Coffee, will not be shared, sold, exchanged, leased, or given to any third party, not connected to the business of supplying products and services Safari Coffee.

Email communications between the sender and the recipient are sent with an expectation of privacy between the two parties. This privacy is compromised if either the sender or the recipient, share personal information or private email content with third parties, without the other's written consent.

Rates and Reviews

Once you provide a review or rating of feedback for Safari Coffee or one of its products or services, you agree that we may publish part or all of your review or rating together with your first name and suburb.

Cookies & Google Adwords

This site uses a feature called 'cookies' to improve the quality of the web site for all our customers and to provide certain features to Safari Coffee. The majority of web browsers automatically accept cookies. However most allow you to instruct your browser to prevent the use of cookies. You can modify your personal settings for 'cookies' in the Options menu of your browser.

This site also uses Google Adwords remarketing services to advertise on third party websites (including Google) to previous visitors to our site. Third-party vendors, including Google, use cookies to show you ads based on your past visits to Safari Coffee website. Any data collected will be used in accordance with our own privacy policy and Google's privacy policy.

Is personal information secure?

Personal information is held in secure electronic databases. Reasonable precautions to safeguard your personal information from loss, misuse, unauthorized access, modification or disclosure are taken. We understand you may have concerns about the security of personal information collected about you from email inquiries. Where no longer required, your personal information is deleted from our systems.

Third-Party Providers

The third-party providers used by Safari Coffee will only collect, use and disclose your personal information to the extent necessary to allow them to perform the services they provide to us. We require these third-party providers to maintain the confidentiality of your personal information and also seek to ensure that they adhere to the Dutch Privacy Principles. These service providers are not permitted to use your personal information for their own marketing purposes.

These third-party service providers have their own privacy policies. We recommend that you read their privacy policies so you understand the manner in which these providers will handle your personal information.

Once you leave our store's website, or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy or our website's Terms of Service.

Can I have access to the personal information Safari Coffee holds about me?

Safari Coffee is not always required to provide you with access. We may refuse access to personal information in a number of circumstances, where the information may relate to existing or anticipated legal proceedings with you, where denying access is required or authorized by law, or where the request is regarded as vexatious or frivolous.
